In the reference 4th read above, Government have re-constituted a committee for examining all Change of Land Use proposals falling in the jurisdiction of Urban Development Authorities, Municipal Corporations, Municipalities and Nagarpanchayats falling within the Master Plan limits in the State with Principal Secretary/Secretary to Government, Municipal Administration & Urban Development Department as Chairman, Metropolitan Commissioner, Visakhapatnam Metropolitan Region Development Authority (VMRDA), Visakhapatnam, Metropolitan Commissioner, Amaravati Metropolitan Region Development Authority(AMRDA), Vijayawada, Director of Town & Country Planning, AP., Vice-Chairperson, Tirupati Urban Development Authority(TUDA), Tirupati as Members and Officer on Special Duty, MA&UD Department as Member/Convenor.

Now, since the AP Capital Region Development Authority Repeal Act, 2020 (Act No. 27 of 2020) and the AP Decentralization and Inclusive Development of All Regions Act, 2020 (Act No. 28 of 2020) were repealed and the AP Capital Region Development Authority Act, 2014 are revived(Act No.11 of 2014) through the reference 5th read above, the change of land use Committee needs to be re-constituted.

3. Government after careful examination of the matter, hereby decided to re-constitute the Committee with the following Members to examine the Change of Land Use proposals:
